

‘4th edition of World Food India from 25-28 September 2025’ at Bharat Mandapam, New Delhi, India

The Ministry of Food Processing Industries (MoFPI), Government of India is holding the ‘4th edition of World Food India (WFI) from **25-28 September 2025**’ at Bharat Mandapam, New Delhi.

2. World Food India 2025 stands as a premier gateway to the rapidly evolving Indian food economy, serving as a dynamic platform for fostering strategic partnerships between Indian and global stakeholders. As a unique convergence of food manufacturers, producers, processors, investors, policymakers, and industry leaders from across the global food ecosystem, the event promises to be a landmark gathering of ideas, innovation, and investment.

3. The Indian food processing sector has made significant strides in recent years under the visionary leadership of the Hon'ble Prime Minister of India, Shri Narendra Modi. To continue the momentum of this growth, World Food India (WFI) has been conceptualized as a gateway to the Indian food economy and an opportunity to showcase, connect and collaborate. It is a premier global food event for stakeholders across the food processing ecosystem, including food producers, processors, equipment manufacturers, logistics and cold chain operators, technology providers, startups, innovators, and food retailers.

The key elements of WFI include exhibitions; conferences and knowledge sessions; industry roundtables with policy makers; B2B/B2G/G2G meetings; digital showcase of technologies, MoFPI Initiatives as well as Food preservation & sustainability; Great Indian Food Street showcasing Indian products & ingredients as well presenting opportunities for fusion with global cuisines; Start-Up Grand Challenge bringing forth technology solutions and new innovations for challenges faced by Indian food processing ecosystem; and, Awards recognizing breakthrough advancements made by Start-ups, innovators, micro entrepreneurs etc..

World Food India 2024 held during 19th to 22nd September 2024 saw remarkable global participation, including 6 International ministerial delegations, 10 International official delegations, 20 country pavilions and 2,390 foreign delegates. The event adopted a comprehensive Whole-of-Government approach, with active support from 9 Ministries and Departments of the Government of India, 8 associate organizations, and 26 States and Union Territories. The event hosted 809 international buyers, 1,557 exhibitors, and facilitated over 18,000 buyer-seller meetings. More than 100 Chief Experience Officers (CXOs) from leading domestic and global companies attended the mega food event, alongside beneficiaries of MoFPI schemes, representatives from academia, domestic buyers, and other key stakeholders. Additionally, the Food Safety and Standards Authority of India (FSSAI) hosted the Global Food Regulators Summit (GFRS)-2024 as an integral part of World Food India-2024.
