Investment from Germany

SCHOTT AG, a German pharma tubing company is investing more than 20 million Euros (approx. Rs. 180 Crores) to construct a new tank facility, to manufacture borosilicate glass tubes to be supplied to the global market. The new facility will begin production by January 2020. SCHOTT AG is celebrating 20 years of operation in India this year.

Zydus Cadila to market Colchicine tablets to US market

Zydus Cadila, an Indian pharma company based in Ahmedabad, received approval from United States Food and Drug Administration (USFDA) to market Colchicine tablets used to treat and prevent gout attacks.

Joint Venture in fuel retail business

Adani group and French major Total SA announces a joint venture to enter fuel retail business with a target to roll out 1,500 outlets in the next 10 years. The JV will develop terminals for importing gas in ships. India's retail market is lucrative with 5-6% annual growth rate.

Inauguration of 'India Business, Start Up, and Innovation Centre'

Make in India- Railway coaches

Indian Railways will start upgrading metro rail coaches using robots at its Rae Bareilly factory under Make in India scheme. The cost would be 40% cheaper than procuring from China and other countries and the coaches will be equipped with wi-fi, CCTV cameras, mobile charging outlets, signaling, door control and other modern surveillance systems.

Punjab set to boost industry development

Government of Punjab decided to amend the Industrial and Business Development Policy 2017 to give investment incentive by way of Net State Goods and Services Tax (SGST) on intrastate sale and also global tendering for the hi-tech valley on a 100-acre industrial park in Ludhiana.

Maharashtra: 1 lakh solar pumps

Under the Mukhya Mantri Saurya Krishipump Yogn (MMSKY) project Maharashtra Government approved the installation of one lakh Solar pumps for agricultural irrigation use in three phases; 25,000 in first phase (2018-19); 50,000 in second phase (2019-20) and 25,000 in third phase (2020-21).

E-Commerce sales in India

India's E-Commerce market is expanding quite rapidly. During the 5-days festive sale that ended on October 14 goods worth approx. USD 2.3 billion (Rs. 150 billion) were sold. Online festive sales during the year 2017 was only USD 1.4 billion. A steep increase in 43% sales value within one year is due to increasing public awareness about online sales.
