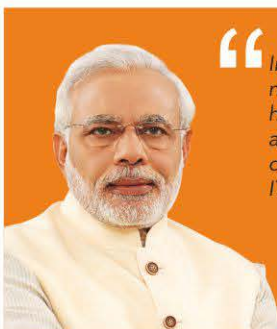
An annual flagship global event for increasing trade in Services, enhancing strategic cooperation and strengthening multilateral relationships between all stakeholders.
