recovered from the contractor's bill, if any worker is found missing/absent. An attendance sheet will be signed by workers daily. The contractor has to arrange attendance register for his staff, which will also be checked and signed by an officer designated by this Embassy. Attested copy of this shall be submitted along with monthly bill. It will be ensured that appropriate type of cleaning materials suited for the cleaning are used. Any damage caused to the property of this building/floor due to unsuitable/harmful cleaning materials or due to the negligence on the part of the workers of the service provider firm will be liable to be compensated by the service provider firm. The contractor shall be responsible for the conduct/integrity of persons deputed cleaning works in the building and will also be responsible for any act of omissions or commissions on their part. He will vouch for their character and integrity. The contractor shall supply fresh sets of uniforms/badges, identity cards, shoes to all personnel who shall wear the same while on work and also keep their uniform neat and clean. If any employee is found without uniform a penalty @ CHF 100/- per person per day shall be recovered from contractor's bill.
