BROAD SPECIFICATIONS OF RANDOM NUMBERING MACHINE:

"Sheet-fed Electronic Sequential and Non-Sequential i.e. Random Numbering Machine" to facilitate Numbering on the printed sheets" with provision to accept data from any server on LAN to print the number on the required job as well as it should have facility to feed the data manually on the machine. The machine should have the following components and the features:

- 1. A suitable feeder with a feed board capacity of minimum 500 sheets shall be provided for feeding of printed sheets.
- 2. Numbering stations:
 - (a) Two numbering stations shall be provided to increase the capacity of numbering as per the requirement of the job.
 - (b) Each numbering shaft shall accommodate at least 02 Nos. of random numbering boxes.
 - (c) The numbering station shall be capable to print/ number the sheet horizontally (straight) as well as vertically.
 - (d) The numbering station shall have provision to mount strike in blocks (Magnetic base) to use steel base of suitable thickness.

- 3. Motorized Random numbering boxes:
- 3.1 The box shall be of Metallic frame, figure height 4.00 mm, 7 digit Numeric Automatic motorized wheels + space + 4 Alpha numeric prefix Automatic motorized wheels. The same box shall be capable to number 6-digit by replacing numeric wheel with low blank wheel or space wheel at 1st Position.

- (ii) Position 8 low blank wheel- space wheel.

- (i) Position 1-6 figure wheels 1 to 0, 11-division motorized by electronic control.
- (ii) Position 7 low blank wheel-spare wheel.

4. Inking Unit

The inking system shall have sufficient numbers of inking rollers, riders, forme rollers to ensure uniform inking of numbering boxes/ print blocks to get excellent print result along with ink duct. Shall have wash up facility.

Suitable delivery unit with stacking of 500 sheets shall be provided.
