The decisive factor for compliance with the deadline is receipt by the Swiss Federal Institute of Intellectual Property (IPI).</p> <p><u>Problem:</u> Detailed product description: The IMMUNO-CAR ZÜRICH (ZURICAR) project, based at the Department of Medical Oncology and Haematology (MOH) in University of Zurich (UZH), is looking for a Contract Manufacturing Organisation (CMO) partner for the complete process development and production of an mRNA, capped, including poly-A-tail, and with complete substitution of N1-methyl-pseudo-U. The desired quality corresponds to a 'high technical quality' - suitable for clinical phase I - comparable to Good Manufacturing Practices (GMP). The process includes all necessary steps, starting with the production of the DNA template, through the production of an mRNA lot, to the fill and finish of the finished product. The tender covers the entire process of producing the SB100X mRNA (mRNA length corresponds to approximately 1 kb), capped, including poly-A-tail, and with full substitution of N1-methyl-pseudo-U, and is divided into the following deliverables and work packages (WP).
